Summary of Dental Benefits

► Welcome

The Butler Health Plan (BHP) is a self-funded dental plan for the exclusive benefit of the eligible employees. Your dental benefits exceed those provided to most employees in the public or private sector and are an important part of your overall compensation.

► Claim Payment

BHP contracts a dental claim administrator to process all your dental claims and pay your provider or you. Dental claim forms are available from your Treasurer or Personnel Department, or the BHP web site. The billing address is on the dental claim form.

► Dental Provider Choice

BHP currently provides one dental plan. This is a Traditional Plan where participants may select their provider and self-refer to specialists. There is no dental network at this time. The BHP Dental Plan Document is available from your Treasurer or Personnel Department, or the BHP web site.

► Coordination of Benefits (COB)

BHP will coordinate benefits with other group dental plans; including a second BHP Dental Plan. The rules used in determining which plan is primary payor and which plan is secondary payor are explained in the BHP Dental Plan Document.
